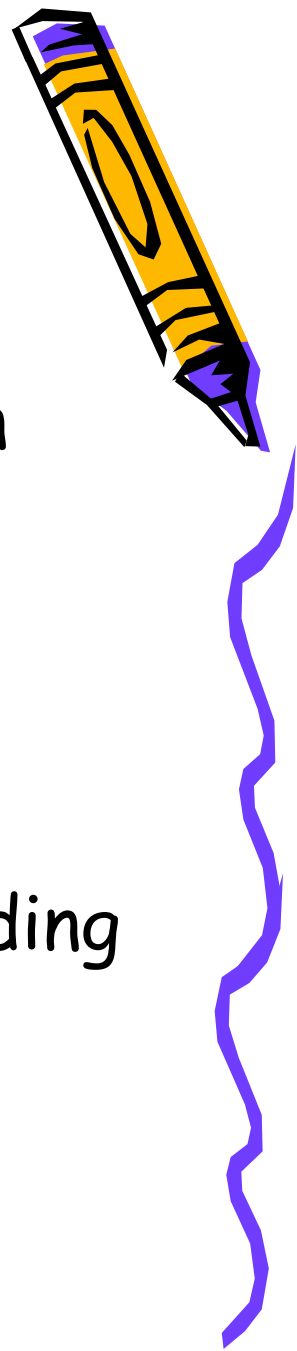

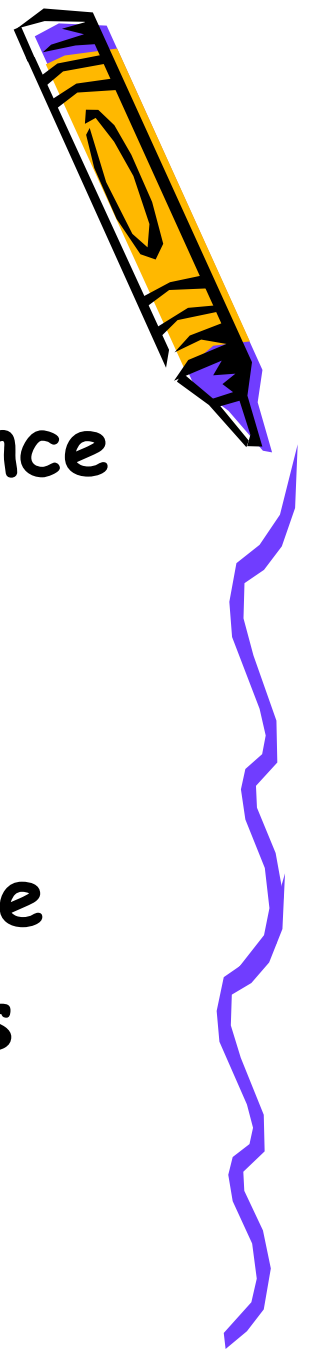

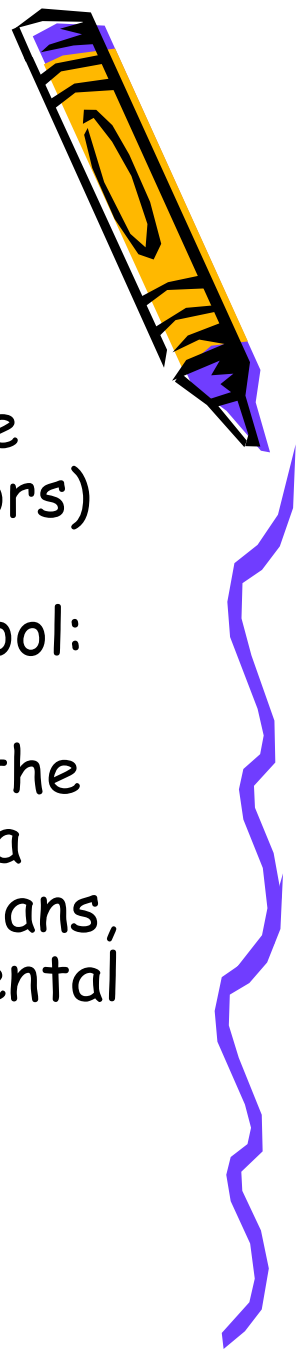
The Law of the Republic of Lithuania on Education

Article 20. Social pedagogical assistance



- 1. The purpose of social pedagogical assistance shall be to help the parents (guardians, curators) so that the child's right to education be exercised, to ensure the child's safety at school: to eliminate reasons because of which a child cannot attend the school or avoids attending the school; to return drop-outs to school; to help a child (in co-operation with the parents (guardians, curators)) choose a school according to his mental and physical abilities and to adapt at school

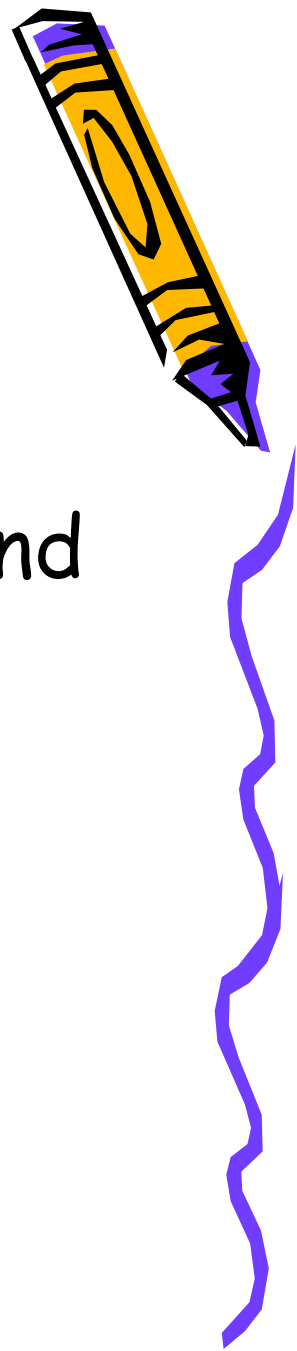


Article 20. Social pedagogical assistance

- When providing social pedagogical assistance to learners, the school shall co-operate with social assistance services, healthcare institutions and law enforcement institutions and shall provide consultations to students' parents (guardians, curators) and teachers



Article 20. Social pedagogical assistance



- The procedure for providing social pedagogical assistance to a child and a learner shall be laid down by the Minister of Education and Science

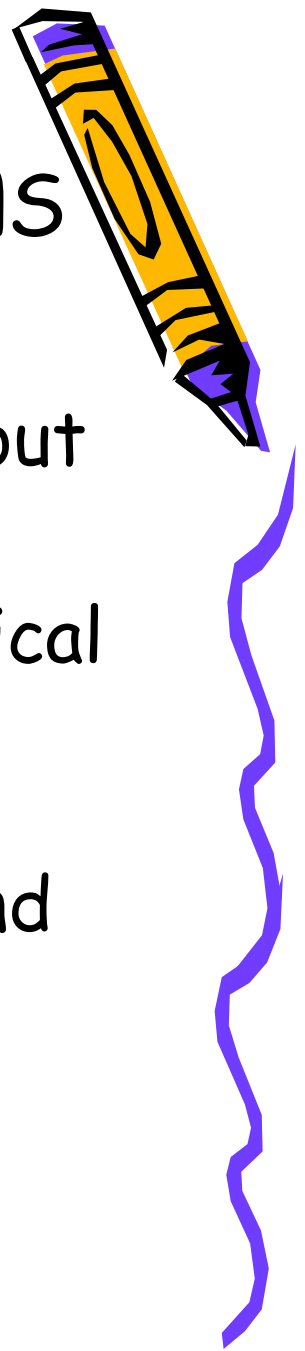


- A sample job description regulates the activities of a social pedagogy working in a school.
- The main objective of the school's social pedagogue's activity is to help implement the right of the child and student to study, to ensure its safety at school and to create the conditions for positive socialization and civic maturity of the child and student



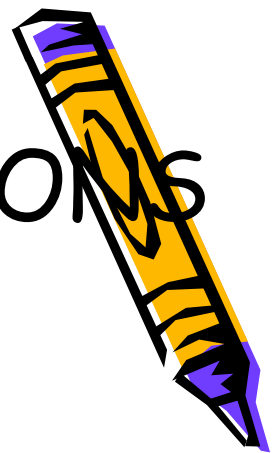
SOCIAL PEDAGOGUE FUNCTIONS AND RESPONSIBILITY

7. The school's social pedagogue carries out the following function:
 - 7.1 assesses the needs of social pedagogical assistance for a child and a student (together with other specialists), may attend classes, non-formal education and other activities, if necessary

7.2 counseling children and pupils,
their parents (carers, caretakers),
school community in solving social-
pedagogical problems, providing
social-pedagogical assistance

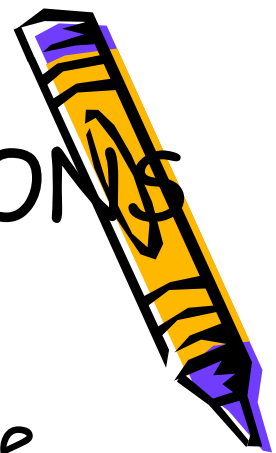


7.3 Participating in crisis situations in school, education and social skills issues;

7.4 provides for methods and forms for the provision of social pedagogical assistance to the child and student

7.5 educates the school community on the provision of social-pedagogical assistance, school non-attendance issues

7.6 initiates and implements preventive activities and social education projects together with the School Child Welfare Commission and other teachers

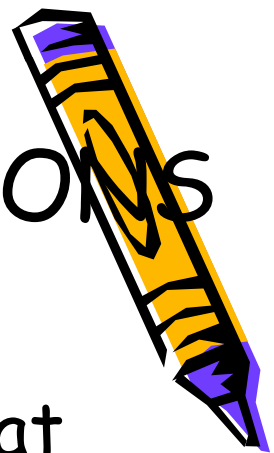

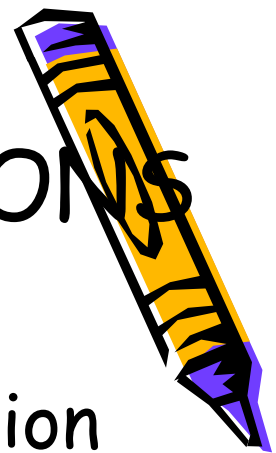
7.7 conducts social pedagogical research at school

7.8 collects and analyzes the information needed to solve the problems of children and students

7.9 disseminates information on social and pedagogical assistance

7.10 Fills in working documents (consultation notes and other relevant documents, child's personal file)

7.11 prepares program of activities for the academic year.

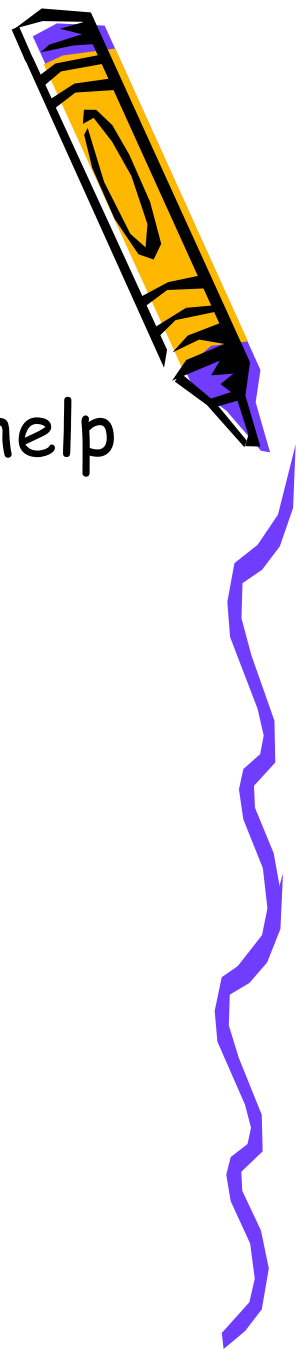
